4.11 WEEE Storage

- 4.11.1.1 The storage (including temporary storage) of WEEE shall be carried out in accordance with the technical requirements of Annex III of the WEEE Directive.
- 4.11.2 Equipment shall be provided to record the weight of untreated WEEE accepted at, and components and materials leaving the site.
